Note: According to School Safety Legislation it is not necessary for volunteers to be fingerprinted to have a criminal history check processed. However, for the protection of our students and staff **all volunteers shall complete a "Disclosure of Criminal History" form and provide the necessary information so that an on-line criminal background check can be processed on a yearly basis (each school year starting July 1).** There is no cost to the volunteer for this procedure. Building Principals will be notified if there is a problem/concern. **Return completed forms to the Spitler Administration Building for processing.**
